This form is to be completed by studying international students wishing to apply to place their studies temporarily on hold. As leave of absence may affect your visa, you are advised to contact Student Services prior to completing this form.

You must read the important information below carefully:

- As an international student you are able to take leave of absence or temporarily put your studies on hold only in certain
 limited circumstances on the grounds of compassionate or compelling circumstances. Compassionate or compelling
 circumstances may include serious illness or injury, involvement in a serious accident or serious illness or
 bereavement of a close family member.
- You must attach **supporting documentation** when applying for leave in the form of **medical certificates**, **boarding pass**, **flight details** or other appropriate documentation.
- The Department of Home Affairs (DHA) allows leave of absence on compassionate or compelling circumstances for a maximum of one semester or six months. If you take leave for more than six months your electronic confirmation of enrolment (eCoE) and your visa will be cancelled. Therefore, before resuming your studies you must obtain a new eCoE from the Admissions Manager and apply for a new student visa.
- In general, you must depart Australia within 14 days from the start date of your leave. You must provide a copy of your air ticket to Admissions Manager. You are only permitted to stay in Australia if your leave of absence is less than 28 days in duration or if you are unable to travel due to medical reasons. In this case a medical certificate must be provided as evidence.
- If you do not provide supporting documents or you have been granted leave for circumstances other than mentioned above UE must inform DHA that you have ceased your studies. In such cases your visa will be cancelled and before resuming your studies you must obtain a new eCoE from the Institute and apply to for a new student visa.
- UE recommends that students contact DHA telephone 131 881 or https://www.homeaffairs.gov.au/ for further advice regarding their individual circumstances.
- NOTE: DHA has discretionary power to cancel a student visa where we defer or suspend the studies of a student visa
 holder because of the student's conduct or our approval is based on fraudulent/misleading evidence relating to the
 deferral/suspension.
